The La Grange Police Department is responsible for overseeing the policing, administrative duties and collection of the associated Regulatory Fees. Licensees generally pay an initial annual fee with their application and on an annual basis. In addition, restaurants and retail stores pay a 5% quarterly Regulatory Fee based on the gross sales of alcohol less one fourth of their annual/renewal fee. The following table details the revenues generated for the City during 2016.
